

# Mortgage Insurance Company Accelerates Security with Reveal

### The company

This customer is a mid-market mortgage insurance provider with over 500 employees. As a publicly traded company they must comply with a wide variety of laws and regulations including the privacy and information security requirements of the Gramm-Leach-Bliley, Dodd-Frank, California Consumer Privacy, Virginia Consumer Data Protection, and Fair Credit Reporting Acts

## The challenges

The company has a mature cybersecurity practice based on National Institute of Standards and Technology (NIST) 800-53. It was previously a division of a larger organization using a legacy DLP solution.


After its spinout from the larger organization, the company needed a solution with less overhead, but couldn't sacrifice data protection. It did not want to dedicate resources from its smaller security team to manage a legacy solution.



This included constantly monitoring, adjusting, and managing granular rules dictating which users could take specific actions with each class of data. As a Microsoft E5 customer, they also needed a solution that could ingest Microsoft Information Protection (MIP) sensitivity labels. Finally, the company wanted a solution that would support a "security culture."


